



2026 EAA Post-Election Report

By-Law Amendment (PAC Contributions)

Prepared by the EAA Election Committee

This report, presented by the Election Committee, is a summary of voting results, protests, and costs for the 2026 special election on amending the By-Laws regarding Political Action Committee Contributions. The election began with an email election announcement to the membership on 03-13-26. The Board President sent a reminder to members on 04-07-26 via EAA's official email list. Voting occurred via the online platform Election Buddy between 04-06-26 at 9 am and 04-10-26 at 12 pm. The unofficial results were announced to the membership on 04-10-26. The protest period was open from 03-13-26 at 9 am to 04-12-26 at 5 pm.

The Election Committee thanks the voters, all candidates, EAA staff - especially Judyth Hermosillo, Jorge Torres, Brenna Green and Marleen Fonseca, and the Election Buddy team for their roles in another successful election season!

RESULTS

The Bylaw amendment passed with 73.16% of the vote. There is no policy in the Election Manual or the Bylaws themselves requiring that a Bylaw amendment pass by a certain percentage, so a simple majority results in a successful amendment. Results are listed below.
